The golden retriever is an intelligent dog bred to work. Although they are serious about their work, they also enjoy being playful. They should have a friendly, gentle temperament, trustworthy with everyone.

Tiera truly exemplifies what a golden retriever should be. I have known her since the November 19, 2001 day her mother, CH Bonacres Legal Tender CD CGC TDI OD, Lovey, put her on the ground.

I have trained my dogs in obedience, agility, field and rally with Tiera and Jane. We have also gone on pet therapy visits with them. Tiera has always demonstrated a kindly, friendly

and confident temperament with a trusting, gentle disposition.

She loves everyone and gets along well with new people and dogs. She is comfortable around people of all ages from babies to senior citizens. Yes, she is concerned if a baby cries, but she can just lie there patently while they are attended to. The same can be said for those in hospitals or nursing homes. She will stand there and be petted or if they want to talk she will just stand or lie and quietly listen. She has a sweet, calm nature which puts those around her at ease.

In her younger days she was used as a demo dog at the park district's dog obedience classes. Here also she demonstrated a tolerant attitude. She was especially calm and even-tempered when the differences between pulling and popping to correct behavior was demonstrated. Tolerance and patience were also present when class attendees might sniff her when their handlers were inquiring about individual issues.

She loves to work and especially enjoyed, before her eyesight got poor, retrieving the paper and bringing it into the house and delivering it to hand. When training for her WC, she especially loved to fetch the bumpers or birds both on land and in the water. In fact, given her and her brother's eagerness to retrieve she assisted in his learning to swim when they both went to retrieve the bumper which was thrown in the water.

She is a calm, biddable golden with an exceptional eagerness to please. Tiera has a patient demeanor waiting quietly before being told what to do. Her intelligence, athleticism and desire to please her handler enabled her to excel in obedience trials. She was exceptionally trainable however she had a bad jumping experience during one of her obedience trials which hindered the continuation of her obedience career and her agility training.

Even up in years she still enjoys being active and having fun. Though it is waning due to her age, Tiera has remained puppy-like. She will still initiate play with her other canine house-mates.


