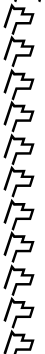

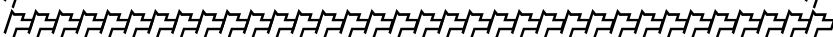
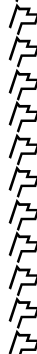

AKC National Owner-Handled Series

(Remember to check the box near the bottom of the entry form)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book and the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

***A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

Attention Owners/Exhibitors of Foreign Registered Dogs

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1.

The dog show rules are posted on the AKC Web site at: <http://images.akc.org/pdf/rulebooks/RREGS3.pdf>

Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, *regardless of whether the dog earned any points or awards*. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at: <http://images.akc.org/pdf/extenap.pdf>

00900. BEST OF BREED COMPETITION

NR2.14500. Parade of Honors (Saturday Only) - The Fort Detroit Golden Retriever Club, Inc. is pleased to offer an Honors Parade to recognize those dogs present at the show which have received an AKC Championship, Agility Excellent Title, Utility Dog Title, Tracking Dog Excellent Title, Master Hunting Title and those dogs qualified as Open All-Age Field Trial. We will also recognize any Golden Retriever designated by the Golden Retriever Club of America as an outstanding Sire or as an outstanding Dam. Each dog entering the Honors Parade will be presented with a Rosette with the dog's name & titles on it. Dogs entered in the Honors Parade need not be entered in any other class in this Specialty Show or Obedience Trial but all information must be submitted on an Official AKC entry blank with Honors Parade as well as the title being honored in the space provided for Additional Classes. A brief write-up on the dog's accomplishments may be given to the Show Chairperson on the day of the event to be read aloud. The Honors Parade will be held during the lunch break.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

NR2.09100. Stud Dog Class - Will be for Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of the Get. Get only to be judged, based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a Regular Class, Best of Breed Competition, or some other Non-Regular Class.

NR2.09200. Brood Bitch Class - Will be for Brood Bitches and two of their Produce. Brood Bitches must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. Owner of Brood Bitch need not necessarily be owner of the Produce. Produce only to be judged, based on the merits of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Produce must be entered in a Regular Class, Best of Breed Competition, or some other Non-Regular Class.

As the judge's decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won these classes.

The judge is permitted to award Judge's Awards of Merit (JAMs) to approximately 10% of the specials entry (as calculated below) in the Best of Breed class, in order to recognize dogs that are especially meritorious. AKC awards in this class are Best of Breed, Best of Opposite Sex to Best of Breed, Best of Winners, and, at the judge's option, Select Dog & Select Bitch. While Best of Breed, Best of Opposite Sex to Best of Breed and Best of Winners are not to be considered for JAMs, any remaining dogs in the class, including the Select Dog & Select Bitch, are to be included for consideration. For purposes of calculating 10% of the specials entry, absent specials are included, but not Non-regular or Winners class dogs that become eligible through competition. No Judge's Awards of Merit are to be awarded unless at least 5 (five) specials are entered. If 5-14 specials are entered, one JAM may be awarded; if 15-24, two JAMs; and so forth.

AKC awards in this class are Best of Breed, Best of Opposite Sex to Best of Breed, Best of Winners, and, at the judge's option, Select Dog & Select Bitch. While Best of Breed, Best of Opposite Sex to Best of Breed and Best of Winners are not to be considered for JAMs, any remaining dogs in the class, including the Select Dog & Select Bitch, are to be included for consideration. For purposes of calculating 10% of the specials entry, absent specials are included, but not Non-regular or Winners class dogs that become eligible through competition. No Judge's Awards of Merit are to be awarded unless at least 5 (five) specials are entered. If 5-14 specials are entered, one JAM may be awarded; if 15-24, two JAMs; and so forth.

All EZ-Ups and Canopies must be taken down at the end of judging your breed or prior to leaving the grounds. The Midway Area, as noted by signage, will accommodate EZ-Ups and Canopies and your vehicle on a first come, first served basis each day. No Power is provided in this area. Should you place your EZ-Up or Canopy near your rings you are required to take it down at the end of each day. In the spirit of good sportsmanship no cones will be allowed to save any spots for the next day. These procedures are required by the Monroe County Fair. Thank you for your assistance in complying with the Fair rules & requirements. We want to continue to have our shows at this great site!

The Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. Two Dog Bathing Stations will be located outside the restroom in the RV Area and two stations will be located outside the grooming tent closest to the Expo Center.

An Overnight Parking fee of \$40.00 is required for any vehicle parked on the grounds overnight, regardless of whether the vehicle uses electricity or is occupied. INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
